## ORDER GRANTING IN PART AND DENYING IN PART REQUEST FOR CONFIDENTIAL CLASSIFICATION OF DOCUMENT NO. 11588-92

On October 5, 1992, Southern Bell Telephone and Telegraph Company (Southern Bell or the Company) filed a Request for Confidential Classification (Request) of certain material submitted in response to Item 53 of Staff's Third Set of Interrogatories. The Commission assigned Document No. 11588-92 to the Company's response.

Florida law provides, in Section 119.01, Florida Statutes, that documents submitted to governmental agencies shall be public records. This law derives from the concept that government should operate in the "sunshine." The only exceptions to this law are specific statutory exemptions and exemptions granted by governmental agencies pursuant to the specific terms of a statutory provision.

Accordingly, pursuant to Section 364.183, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, it is the Company's burden to show that the material submitted is qualified

for specified confidential classification. Rule 25-22.006 provides that the Company may fulfill its burden by demonstrating that the documents fall into one of the statutory examples set forth in Section 364.183 or by demonstrating that the information is proprietary confidential information, the disclosure of which will cause the Company or its ratepayers harm.

To this end, Southern Bell asserts that the material at issue encompasses unregulated itemized expenses, net income, forecasted revenues/expenses regarding BellSouth Advertising and Publishing Company (BAPCO) which the Company contends confidential proprietary business information pursuant to Section 364.183(3)(e), Florida Statutes. It is the Company's view that knowledge of discrete elements in BAPCO's cost structure, such as current and projected printing, commission and other costs in the context of the directory advertising business, would make it easier for competitors to estimate BAPCO's overall costs which must be covered through advertising revenues. The material at issue is found on page 2 of 2, columns 1992 and 1993, lines 11-19.

Upon review, the material is found to be forecasted information. Disclosure of the forecasted information in column 1993 would cause BAPCO competitive harm. Thus, it is found to be confidential proprietary business information pursuant to Section 364.183(3)(e), Florida Statutes. Such information is exempt from the disclosure requirements of Section 119.07(1), Florida Statutes. Accordingly, the Company's Request regarding this material shall be granted.

However, the Company has failed to adequately demonstrate how forecasted data regarding a previous year would cause competitive harm. It is noted that analogous 1991 information was disclosed as a response to a staff data request dated May 15, 1992. Therefore, the Request as it applies to information contained in column 1992 is denied.

Based on the foregoing, it is

ORDERED by Commissioner Susan F. Clark, as Prehearing Officer, that Southern Bell Telephone and Telegraph Company's October 5, 1992, Request for Confidential Classification of Document No. 11588-92 is granted in part and denied in part as set forth in the body of this Order. It is further

should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.038(2), Florida Administrative Code, if issued by a Prehearing Officer; (2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or (3) judicial review by the Florida Supreme Court, in the case of an electric. gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of Records and Reporting, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
