Attachment A of that Order, which described the additional territory Southern States requested to serve, contains an error. The territory description for Western Shores shown on the first page of Attachment A (Page 6 of the Order), incorrectly indicates that Sections 7 and 18 are in Township 19 South, Range 25 East. The territory description is hereby amended to reflect that Sections 7 and 18 are in Township 19 South, Range 26 East. The correct territory description is shown on Attachment A of this Order, which by reference is incorporated herein.

ORDERED by the Florida Public Service Commission that Order No. PSC-93-0754-FOF-WU is hereby amended to reflect the correct territory description as shown on Attachment A of the instant Order. It is further

ORDERED that Order No. PSC-93-0754-FOF-WU is hereby affirmed in all other respects.

## NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water or sewer utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Civil Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
