 FICA members own and/or operate highly efficient cogeneration facilities in conjunction with various industrial manufacturing, processing or refining operations at locations throughout the State of Florida.

- 4. Some FICA members purchase electric power from and sell firm and/or asavailable cogenerated electric power to Florida Power Corporation (FPC). Those members
 are included under Groups "B" and "C" in FPC's "Generation Curtailment Plan For Minimum
 Load Conditions" (Curtailment Plan) which is the subject of this proceeding.
- FICA members who neither purchase electric power from nor sell electric power to FPC will nonetheless be affected by the decision in this proceeding since, as FPC states in its Curtailment Plan,

During periods of low minimum load for Florida Power Corporation, other utilities in Florida and the southeast are likely to be facing similar if not the same low load conditions. (at page 9)

Accordingly, all FICA members will be impacted directly or indirectly by the actions of FPC in response to low load conditions on its system.

- The issues raised and the solutions proposed by FPC present this Commission with a case of first impression. Indeed, it was reported recently in the industry trade press that FPC's October 18th and 19th QF curtailments under the Curtailment Plan were believed to be the first time QF's have been curtailed in the U.S. Regardless of whether this report is accurate, it is clear that the precedent established by the Commission in resolving the issues presented in this Docket will broadly impact on Florida QF's in general.
- 7. The substantial interests of FICA and its members will unquestionably be affected by the Commission's resolution of matters within the scope of this proceeding.

WHEREFORE, FICA and its members respectfully request entry of an order granting it leave to intervene as a full party in interest to this proceeding.
