Declaratory Statement proceedings are exempt from the provisions of section 350.042, Florida Statutes; nevertheless, I believe it is appropriate to disclose the substance of our meeting on the record of this proceeding. The following paragraphs summarized the substance of our meeting. Please place this memorandum on the record of the above-referenced proceeding. It is not necessary to disseminate this memorandum to the parties for comment due to the fact that this proceeding is exempt from the provisions of section 350.042, F.S.

The gentlemen represented that they were in support of Panda-Kathleen LP's cogeneration project in Polk County, Florida. They stated that the project would benefit the County by providing jobs and by providing significant tax revenues. They indicated that the County has served as host for several other cogeneration projects with favorable results.

Mr. Stiles and I indicated that the Commission would not be addressing the merits of the declaratory statement at today's Agenda. Rather, we explained that the Commission would be simply addressing some procedural matters regarding the scope of the issues to be addressed in the proceeding.
