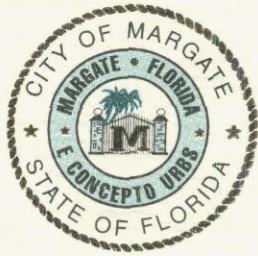

A RESOLUTION OF THE CITY OF MARGATE, FLORIDA,  
SUPPORTING SOUTHERN BELL'S PLAN FOR EXTENDED  
CALLING SERVICE BETWEEN LOCAL COMMUNITIES TO  
PROVIDE REDUCED RATES FOR RESIDENTIAL AND  
BUSINESS CUSTOMERS.

WHEREAS, Southern Bell has proposed a plan to the Florida Public Service Commission to offer Extended Calling Service between communities with a demonstrated community of interest; and

WHEREAS, Southern Bell's Extended Calling Service is a simpler calling plan than many of the optional plans currently available; and

WHEREAS, Southern Bell's Extended Calling Service provides reduced rates for both residential and business customers;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

SECTION 1: That the foregoing preamble is hereby ratified and confirmed as true and correct by the City Commission of the City of Margate, Florida.

SECTION 2: That the City Commission of the City of Margate, Florida hereby urges the Florida Public Service Commission to approve Southern Bell's proposed tariff filing for Extended Calling Service.

SECTION 3: That a copy of this Resolution shall be forwarded to the Florida Public Service Commission.

SECTION 4: That this Resolution shall become effective immediately upon its passage.
