Issue 4: Recommendation that the Commission, on its own motion, should require Southern States Utilities' initial customer notice to be supplemented as set forth in Attachment A of staff's memorandum dated November 14, 1995. Further, a copy of the supplemental notice should be mailed to each customer within 14 days of the Commission vote and should be attached to each synopsis. No additional customer service hearings should be required, but the parties may move for leave to file supplemental prefiled testimony if any customer comments so require it. Such supplemental testimony shall be strictly designed to respond only to the customer comments.
