NOTICE OF PROPOSED AGENCY ACTION ORDER APPROVING TERRITORIAL AGREEMENT

NOTICE IS HEREBY GIVEN by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

BY THE COMMISSION:

On August 30, 1995, Lee County Electric Cooperative, Inc. (Lee) and Glades Electric Cooperative, Inc. (Glades) filed a petition for approval of a territorial agreement. Authority to approve such agreements is governed by Section 366.04(2)(d), Florida Statutes.

The purpose of this agreement is to identify Lee's and Glades' respective service areas in portions of Hendry and Collier counties. Exhibit "1" to the agreement is a map of the respective territorial boundaries within the previously mentioned counties. Exhibit "2" and Exhibit "3" are listings of customer accounts and related facilities that will be subject to transfer pending approval of this agreement. Once the transfer of customers and facilities is complete, neither utility will be serving customers outside its respective service area.

Section 2.2 of the agreement states that neither utility will knowingly serve or attempt to serve any customer whose end-use

facilities are located within the territorial area of the other utility, except in the case of exceptional circumstances, economic constraints, or good engineering practices and upon written request. The utilities shall notify the Commission and seek approval of all interim service that lasts or is expected to last for more than one year prior to providing temporary service. Of course, if the parties wish to make a permanent boundary change, they must also seek prior approval from the Commission.

Upon receiving subsequent approval by the Rural Utilities Service (RUS), United States Department of Agriculture (DOA) and the National Rural Utilities Cooperative Financing Corporation (NRUCFC), 74 customer accounts and related facilities will be transferred from Glades to Lee. We conclude that transferring customers will not suffer a decrease in the reliability of electric service. The customers currently receive service from a substation located 27 miles away in Hendry County. Upon transfer, the customers will be receiving service from a substation located only 15 miles away. Though both systems are radially fed, less line exposure decreases the likelihood of an outage. In addition, service crews presently dispatch to the transferring area from the Town of Moore Haven, located 54 miles away, while Glades will dispatch crews from the Town of Immokalee, located just 15 miles Therefore, as with the probability of an outage occurring, the response time to an outage should also decrease.

All affected customers were notified of the proposed transfer by letter and advised of the difference in rates. This notice included a rate comparison for both residential and commercial customers for varying monthly KWH usages. Three customers responded to the notification but made no indication of preference. The customers merely wanted to verify that there would not be a decrease in their present level of service.

Glades will refund membership fees and security deposits directly to the transferring customers after deducting the balance from their last bill. The capital credits associated with the customers transferring from Glades to Lee will be returned on the normal return cycle as if the transferring customers remained with Glades.

Section 4.2 of the agreement requires that approval from the RUS, DOA and the NRUCFC be obtained prior to the transfer and subsequent payment of electrical facilities. In the event approval is not obtained from either of these entities, the utilities shall notify the Commission as to their next course of action.

The agreement between Lee and Glades will remain in effect for a period of 25 years from the date of the Commission Order. In addition, the agreement will be automatically renewed for an additional 25 years unless either party gives written notice of intent not to renew at least six months prior to the expiration of any 25 year period. Each renewal of the agreement and any proposed modification of the agreement must be approved by the Commission prior to becoming effective.

We hold that this agreement is in the public interest and that its adoption will further the Commission's policy of avoiding unnecessary and uneconomic duplication of facilities. In addition, we conclude that transferring customers will not suffer a decrease in the reliability of electric service. The utilities shall notify the Commission and seek approval of all interim service that lasts or is expected to last for a period greater than one year. The utilities shall also notify the Commission in the event the Rural Utilities Service, the Department of Agriculture or the National Rural Utilities Cooperative Financing Corporation does not approve the proposed agreement.

Based on the foregoing, it is hereby

ORDERED by the Florida Public Service Commission that the territorial agreement entered into by Lee County Electric Cooperative, Inc. and Glades Electric Cooperative, Inc., as attached and incorporated herein, is approved. It is further

ORDERED that Lee County Electric Cooperative, Inc. and Glades Electric Cooperative, Inc. notify the Commission and seek approval of all interim service that lasts or is expected to last for a period greater than one year. It is further

ORDERED that Lee County Electric Cooperative, Inc. and Glades Electric Cooperative, Inc. notify the Commission in the event the Rural Utilities Service, the Department of Agriculture or the National Rural Utilities Cooperative Financing Corporation does not approve the agreement. It is further

ORDERED that this Order shall become final and effective and this docket shall be closed unless an appropriate petition for formal proceedings is received by the Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date indicated in the Notice of Further Proceedings or Judicial Review.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

The action proposed herein is preliminary in nature and will not become effective or final, except as provided by Rule 25-22.029, Florida Administrative Code. Any person whose substantial interests are affected by the action proposed by this order may file a petition for a formal proceeding, as provided by Rule 25-22.029(4), Florida Administrative Code, in the form provided by Rule 25-22.036(7)(a) and (f), Florida Administrative Code. This petition must be received by the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on December 18, 1995.

In the absence of such a petition, this order shall become effective on the day subsequent to the above date as provided by Rule 25-22.029(6), Florida Administrative Code.

Any objection or protest filed in this docket before the issuance date of this order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.

If this order becomes final and effective on the date described above, any party substantially affected may request judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or by the First District Court of Appeal in the case of a water or wastewater utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days of the effective date of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.

AGREEMENT

MITHESSETH:

Section 0.2: WHEREAS, LCEC and GEC, by virtue of Chapter 425, Florida Statutes, and the Charters issued to them thereunder, are authorized and empowered to furnish electricity and power to their members, governmental agencies and political subdivisions, and to other persons, as defined by the laws of Florida, and pursuant to such authority, presently furnish electricity and power to members and customers in areas of Southwest Florida; and

<u>Section 0.3</u>: WHEREAS, the respective areas of service of the Parties are contiguous in many places, and the Parties seek to minimize costs to their respective rate payers by avoiding duplication of transmission and distribution facilities; and

<u>Section 0.4</u> . WHEREAS, the Florida Public Service Commission (herein called the "Commission"), has previously recognized that any such duplication of facilities results in needless and wasteful expenditures and may create hazardous situations, both being detrimental to the public interest; and

<u>Section 0.5</u>: WHEREAS, the Parties desire to continue to avoid and eliminate the circumstances giving rise to potential

duplication of facilities and hazardous situations, and in furtherance of such desire have established Territorial Boundary Lines to delineate their respective retail Territorial Areas, subject to the approval of the Commission; and

Section 0.6: WHEREAS, the Commission is empowered by Section 366.04(2)(d), Plorida Statutes, to approve territorial agreements and resolve territorial disputes between rural electric cooperatives under its jurisdiction, has often recognized the wisdom of such territorial agreements, and has held that such agreements, when properly presented to the Commission, are advisable in proper circumstances, and, indeed, in the public interest;

Section 0.7: NOW, THEREFORE, in consideration of the premises aforesaid and the mutual covenants and agreements herein set forth the Parties hereby agree as follows:

ARTICLE I

DEFIBITIONS

Section 1.1: Territorial Boundary Line. As used herein, the term "Territorial Boundary Line" shall mean the boundary lines which circumscribe the geographic areas shown on the map attached hereto as Exhibit "1", which differentiate and divide the GBC Territorial Area from the LCBC Territorial Area.

Section 1.2: GIADES ELECTRIC COOPERATIVE, INC. Territorial Area. As used herein, the term "GEC Territorial Area" shall mean the geographic area shown on composite Exhibit "1" and designated Glades Electric Co-op.

Section 1.3: LEE COUNTY ELECTRIC COOPERATIVE, IRC.

Territorial Area. As used herein, the term "LCEC Territorial

Area" shall mean the geographic area shown on composite Exhibit
"1" and designated Lee County Electric Co-op.

Section 1.4: Transmission Line. As used herein, the term "Transmission Line" shall mean any Transmission Line of either party having a rating of 69 kV or greater.

Section 1.5: Distribution Line. As used herein, the term "Distribution Line" shall mean any Distribution Line of either party having a rating of up to, but not including 69 kV.

Section 1.6. New Customer. As used herein, the term "New Customer" shall mean any person that applies to either GEC or LCEC for retail electric service after the effective date of this Agreement.

Section 1.7. End-Use. As used in this agreement, the term "end use" means the use of electric energy by a customer at a geographic location where the electric energy is ultimately consumed.

Section 1.8. End-Use Facilities. As used in this agreement, the term "end-use facilities" means those facilities at a geographic location where the electric energy used by a customer is ultimately consumed.

ARTICLE II

AREA ALLOCATIONS AND NEW CUSTOMERS

<u>Section 2.1:</u> <u>Territorial Allocations</u>. Except as otherwise specifically provided herein, during the term of this Agreement GEC shall have the exclusive authority to furnish retail electric service for end-use within the GEC Territorial Area and LCEC shall have the exclusive authority to furnish retail electric service for end-use within the LCEC Territorial Area.

<u>Section 2.2</u>: <u>Service to New Customers</u>. The Parties agree that neither of them will knowingly serve or attempt to serve any new customer whose end-use facilities are located within the Territorial Area of the other party, except as specifically

provided in this Section of this Agreement.

The Parties recognize that in exceptional circumstances, economic constraints or good engineering practices may indicate that a customer's end-use facilities either cannot or should not be immediately served by the Party in whose Territorial Area the customer's end-use facilities are located. In such instances, upon written request by the party in whose Territorial Area the end-use facilities are located, to the other party, the other party may agree in writing to temporarily provide service to such customer's end-use facilities.

Subject to the exceptions for temporarily providing service provided for in the immediately preceding paragraph, in the event that new customer or prospective new customer requests or applies for service from either party to be provided to end-use facilities located in the Territorial Area of the other party, the party receiving such a request or application shall refer the new customer or prospective new customer to the other party with citation to this Agreement as approved by the Commission.

ARTICLE III

OPERATION AND MAINTENANCE

Section 3.1: Pacilities to Remain. Except as expressly provided herein, a generating plant, transmission line, substation, distribution line or related facility now or hereafter constructed or used by either party in conjunction with its electric utility system, which is directly or indirectly used and useful in service to its customers by either of the Parties, shall be allowed to remain where situated and shall not be subject to removal or transfer hereunder; provided, however, that each party shall operate and maintain all such plants, lines, substations or facilities in such a manner as to minimize any

interference with the operations of the other party...

Section 3.2: TRANSFER OF FACILITIES & CUSTOMERS. In order to initially establish the territorial boundary line between the territorial areas of LECO and GEC, GEC agrees to transfer certain electrical facilities and customers. A summary of the number and class of customers of GEC to be transferred under the terms of this agreement is identified as Exhibit 2 and attached as a part of this agreement. A summary of the electrical facilities of GEC with values established by mutual agreement of the two parties is attached, made a part of this agreement, and identified as Exhibit 3. Upon the execution of this agreement and its subsequent approval by the Florida Public Service Commission and the Rural Utilities Service as provided for in Article V below, LCEC agrees to pay GEC Forty Thousand, Six Hundred Seventy One Dollars (\$40,671.00).

In order to insure that all customers who are to be transferred from GEC to LCEC will be fully informed prior to any such transfer a representative of LECO and a representative of GEC shall contact each such customer and explain fully any changes affecting the customer.

ARTICLE IV

PREREQUISITE APPROVAL

Section 4.1: Commission Approval. The provisions and the Parties' performance of this Agreement are subject to the regulatory authority of the Commission, and appropriate approval by that body of the provision of this Agreement shall be an absolute prerequisite to the validity, enforceability, and applicability hereof. This Agreement shall have no effect whatsoever until that approval has been obtained, and the date of the Commission's order, if any, granting initial Commission

approval of this Agreement shall be deemed to be the effective date of this Agreement. Any proposed modification to this Agreement shall be submitted to the Commission for approval. In addition, the Parties agree to jointly petition the Commission to resolve any dispute concerning the provisions of this Agreement or the Parties' performance of this Agreement.

Esction 4.2: Rural Utilities Service Approval. The transfer of electrical facilities by GEC to LCEC as provided in Article IV, paragraph 4 above is subject to the approval of the Rural Utilities Service, United States Department of Agriculture and the National Rural Utilities Cooperative Financing Corporation. The appropriate approval by the Rural Utilities Service, United States Department of Agriculture and the National Rural Utilities Cooperative Financing Corporation shall be a preprequisite to the payment by LCEC for the facilities and the transfer of such facilities to LCEC by GEC.

Section 4.3: No Liability in the Event of Disapproval. In the event approval of this Agreement pursuant to Section 4.1 hereof is not obtained, neither party will have any cause of action against the other arising under this document or on account of such nonattainment of approval.

ARTICLE V

DURATION

<u>Section 5.1</u>: This Agreement shall continue and remain in effect for a period of twenty five (25) years from the date of the Florida Public Service Commission's initial Order approving this Agreement, and shall be automatically renewed for additional twenty five (25) year periods unless either party gives written notice to the other of its intent not to renew at least six (6) months prior to the expiration of any twenty five (25) year

period; provided, however, that each such renewal of this Agreement shall require prerequisite approval of the Commission with the same effect as the original Commission approval of this Agreement as required and provided for in Article V hereof.

ARTICLE VI

CONSTRUCTION OF AGREEMENT

Section 6.1: Intent and Interpretation. It is hereby declared to be the purpose and intent of the Parties that this Agreement shall be interpreted and construed, among other things, to further this the Commission's policy of approving territorial agreements between and among rural electric cooperatives, municipal electric utilities, and other electric utilities under its jurisdiction; to further the Commission's policy of actively regulating and supervising the service territories of electric utilities; and supervising the planning, development, and maintenance of a coordinated electric power grid throughout Florida; and avoiding uneconomic duplication of transmission and distribution facilities.

ARTICLE VII

MISCELLAMEOUS

Section 7.1: Megatiations. Regardless of any other terms or conditions that may have been discussed during the negotiations leading up to the execution of this Agreement, the only terms or conditions agreed upon by the parties are those set forth herein, and no alteration, modification, enlargement or supplement to this Agreement shall be binding upon either of the Parties hereto unless the same shall be in writing, attached hereto, signed by both of the parties and approved by the Commission in accordance with Article IV, Section 4.1 hereof.

Section 7.2: Successors and Assigne: for Benefit only of

Parties. This Agreement shall be binding upon the Parties hereto and their respective successors and assigns. Mothing in this Agreement, expressed or implied, is intended, or shall be construed, to confer upon or give to any person other than the Parties hereto, or their respective successors or assigns, any right, remedy, or claim under or by reason of this Agreement, or any provision or condition hereof; and all of the provisions, representations, condition hereof; and all of the provisions, representations, covenants, and conditions herein contained shall inure to the sole benefit of the Parties or their respective successors or assigns.

EXHIBIT I TERRITORIAL BOUNDARY MAP


