NOTICE OF PROPOSED AGENCY ACTION
ORDER GRANTING CERTIFICATE TO PROVIDE INTEREXCHANGE
TELECOMMUNICATIONS AND ALTERNATIVE OPERATOR SERVICES

BY THE COMMISSION:

NOTICE IS HEREBY GIVEN by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding in accordance with Rule 25-22.029, Florida Administrative Code.

The entity listed in the caption of this Order filed an application for a Certificate of Public Convenience and Necessity to provide interexchange telecommunications and alternative operator services. The application contains the required background information and the proposed tariffs. Having considered this application, it appears that it is in the public interest to grant the requested certificate to provide interexchange telecommunications and alternative operator services. Interexchange telecommunications service providers are charged with the responsibility of complying with the provisions of Chapter 364, Florida Statutes, and Chapters 25-4 and 25-24, Florida Administrative Code. Moreover, pursuant to the provisions of Order No. 16804, interexchange telecommunications service providers are prohibited from constructing facilities to bypass a local exchange company without express prior approval from this Commission. Alternative operator service providers are subject to our decisions in Docket No. 871394-TP, including, but not limited to, Order No. 20489, issued December 21, 1988.

This docket will be closed following the expiration of the period specified in the Notice of Further Proceedings or Judicial Review section of this Order unless an appropriate petition is filed by one whose substantial interests may or will be affected by this proposed agency action, as provided in Rules 25-22.029 and 25-22.036(7)(a), Florida Administrative Code.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that we hereby grant, to the applicant listed in the caption of this Order, a certificate to provide interexchange telecommunications service and alternative operator service subject to the conditions stated in the body of this Order. It is further

ORDERED that the entity shall operate under the corresponding certificate number as listed in the body of this Order. It is further

ORDERED that, unless a person whose substantial interests are affected by the action proposed herein files a petition in the form and by the date specified in the Notice of Further Proceedings or Judicial Review, the certificate shall become effective on the following date and this docket shall be closed.
