PURPOSE: The purpose of the workshop is to gather information concerning Rule 25-6.049, Florida Administrative Code, to determine whether any policy changes should be made. In particular, the following items will be discussed: (1) whether it is appropriate to allow entities other than utilities to be responsible for the individual metering requirements set forth in the rule; (2) whether the Commission should continue to require timeshare facilities and marina slots to be individually metered; (3) whether "flat rates" should be singled out in 25-6.049(1); (4) whether the cost descriptions in 25-6.049(5)(b)6. should be clarified; and (5) whether the submetering responsibilities in 25-6.049(5)(b)6. and 7. should be better defined. All interested persons should come prepared to discuss the above items.
