Issue 2: Recommendation that, if no person whose substantial interests are affected files a protest within 21 days of the issuance date of the order, the provider will have 30 days from the date the order becomes final to pay a $\$ 250$ fine and all past due regulatory assessment fees or their certificate will be canceled without further Commission action and the dockets closed.
