# OBJECTIONS OF MCI TO GTE FLORIDA INCORPORATED'S FIRST REQUEST FOR PRODUCTION OF DOCUMENTS

MCI Telecommunications Corporation and MCImetro Access Transmission Services, Inc. ("MCI"), pursuant to Rules 25-22.034 and 25-22.035, Florida Administrative Code and Rules 1.340 and 1.280(b), Florida Rules of Civil Procedure, hereby submit the following Objections to GTE Florida Incorporated's ("GTE") First Request for Production of Documents to MCI.

The Objections stated herein are preliminary in nature and are made at this time for the purpose of complying with the ten-day requirement set forth in the procedural order previously issued in the above-referenced docket. Should additional grounds for objection be discovered as MCI prepares its Responses to the above-referenced request for production of documents, MCI reserves the right to supplement, revise, or modify its objections at the time that it serves its Responses on GTE. Moreover, should MCI determine that a Protective Order is necessary with respect to any of the material requested by GTE, MCI reserves the right to file a motion with the Commission seeking such an order at the time it

## Objections to Request for Production Nos. 1 - 3, 6 - 20, 24 - 39, 41, 43 - 45, 49 and 50:

MCI objects to these Requests for Production of Documents on the grounds that the documents requested are irrelevant, overly broad, unduly burdensome, oppressive, and not reasonably calculated to lead to the discovery of admissible evidence.

## Objections to Requests for Production Nos. 4 and 5:

MCI objects to these Requests for Production of Documents on the grounds that the documents requested are irrelevant, overly broad, unduly burdensome, oppressive, and not reasonably calculated to lead to the discovery of admissible evidence. Moreover, they seek documents which are subject to attorney/client, work product, and trade secrets privileges. The scope of this proceeding is to determine the obligations of GTE pursuant to the Telecommunications Act of 1996. MCI's plans to enter the local exchange market and any information related thereto are not within the scope of this proceeding.

# Objections to Requests for Production Nos. 21 - 23, 40, 46, and 47:

MCI objects to these Requests for Production of Documents on the grounds that the documents requested are irrelevant, and not reasonably calculated to lead to the discovery of admissible evidence. Moreover, the requests are overly broad, unduly burdensome, oppressive, and seek information that is subject to the trade secrets privilege and that is beyond the scope of this proceeding.
