ARTICLES OF INCORPORATION
OF
RAINTREE DEVELOPMENT OF LEE COUNTY, INC.

These Articles of Incorporation are executed by the under-
signed for the purpose of forming a corporation pursuant to the
Florida General Corporation Act, as particularly set forth in
Chapter 607 of the Florida Statutes.

ARTICLE I. NAME.

The name of this corporation shall be RRAINTREE DEVELOPMENT OF
LEE COUNTY, INC.

ARTICLE II. DURATION.

The corporation shall commence upon filing of these Articles
and shall have perpetual existence thereafter.

ARTICLE III. PURPOSE.

The purpose for which the corporation is organized is the
transaction of any and all lawful business for which a corporation
may be incorporated under the Florida General Corporation Act, as
the same may from time to time be amended.

ARTICLE IV. CAPITAL STRUCTURE.

The aggregate number of shares of capital stock which this
corporation shall have authority to issue shall be 7,500 shares of
common stock, all of the same class and each having a par value of
one dollar (\$1.00).

ARTICLE V. INITIAL REGISTERED AGENT & OFFICE.

ARTICLE VI. DIRECTORS.

The business and the affairs of this corporation shall be managed by a Board of Directors, which shall be elected by the shareholders and serve as provided in the Bylaws. ARTICLE VIII. BYLAWS.

The power to adopt, alter, amend or repeal bylaws shall be vested in both the Board of Directors and the shareholders.

Bylaws adopted, altered, amended or repealed by the shareholders of the corporation may not be repealed, altered, amended or re-adopted by the Board of Directors if the shareholders so provide.
