Florida Public Utilities Company ("FPU"), by and through its undersigned counsel, submits this Amended Petition for the approval of a Purchased Gas Adjustment Recovery Factor ("PGA factor") of 52.114 cents-per-therm for the period April 1997 through March 1998. In support of its Petition, FPU states as follows:

- 1. On January 20, 1997, FPU submitted its Petition, testimony and exhibits in support of a PGA factor of 57.569 cents-per-therm. FPU recently became aware of an error in its calculations that resulted in an understatement of the projected revenues for the period April 1996 through March 1997 and an overstatement of the projected PGA factor for the period April 1997 through March 1998.

Based upon its projected sales, FPU projects that the net CAF _______ under-recovery to be collected during the period April 1997 through CIR ______ March 1998 is \$1,236,383, and FPU's appropriate PGA factor for the EAG ______ Period April 1997 through March 1998 is a maximum of 52.114 cents-LEG _____ Per-therm.
