

MOTION TO EXPEDITE RESPONSE TO DISCOVERY

The Citizens of the State of Florida (Citizens), by and through their undersigned attorney, move the Commission to order Gulf Utility Company (Gulf, Utility or Company) to provide Citizens' Document Request No. 49 on or before Thursday, February 27, 1997, the date discovery is to be completed in this docket. As grounds therefore the Citizens state:

- 1. Pursuant to the requirements of Commission Rule 25-22.034, F A C, and Rule 1 350, Fla. R. Civ. Procedure, Gulf would normally have thirty (30) days in which to provide Citizens' Document Request No. 49.
- 2. However, Rule 1.350, Fla. R. Civ. Procedure, permits the Court or tril inal in its discretion to allow a shorter or long time to provide requested documents.
- an annual survey of the nine companies that operate in Lee County Although witness Moore draws a number of conclusions from the 1996 salary survey, conducted by Pine Island Water Company, he only attached a single page exhibit, JWM-6, summarizing data taken from the survey. The Citizens believe it is important to have a complete copy of the survey available to test the validity of Mr—Moore's conclusions.
 - The report that the Citizens seek is in the possession of Gulf and a copy can be provided by Thursday, February 27, 1997, without undue hards sip.
