Enclosed, we have provided the required Florida Public Service Commission forms requesting incoming call blocking.

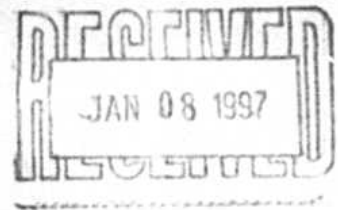
