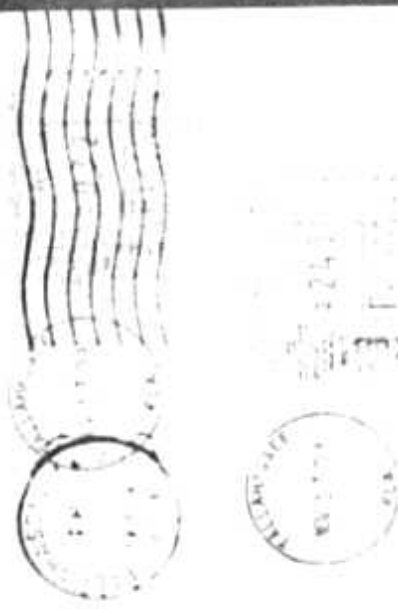

NOTICE OF PROPOSED AGENCY ACTION
ORDER IMPOSING FINE, REQUIRING PAYMENT OF REGULATORY ASSESSMENT
FEES AND REQUIRING INFORMATION IN ACCORDANCE WITH RULE 25-24.520,
FLORIDA ADMINISTRATIVE CODE, OR CANCELING PAY TELEPHONE
CERTIFICATE AND DIRECTING CERTIFICATED LOCAL EXCHANGE COMPANIES
TO DISCONTINUE SERVICE

BY THE COMMISSION:

NOTICE IS HEREBY GIVEN by the Florida Public Service
Commission that the action discussed herein is preliminary in
nature and will become final unless a person whose interests are
substantially affected files a petition for a formal proceeding,
pursuant to Rule 25-22.029, Florida Administrative Code.

Visions by Lyons Inc. (Visions) currently holds Certificate
of Public Convenience and Necessity Number 3607, issued by the
Commission on November 16, 1993, authorizing the provision of pay
telephone service. Visions has not paid the regulatory assessment
fees required by Section 364.336, Florida Statutes, and Rule 25-
4.0161, Florida Administrative Code, for the year 1996. The

regulatory assessment fee form was mailed to Visions in December, 1996, for the period of January 1, 1996, through December 31, 1996. Pursuant to Rule 25-4.0161(2), Florida Administrative Code, the form and applicable fees are due to the Florida Public Service Commission by January 30 of the subsequent year. Visions was notified of its delinquency on June 3, 1997. Visions has been given adequate opportunity to pay. The Commission's correspondence regarding the regulatory assessment fees was returned, marked "unable to forward". To date, Visions has not paid the required fee(s).

The return of these materials indicates that Visions may have violated Rule 25-24.520(1)(a), Florida Administrative Code, which requires the reporting to the Commission of an address change within ten (10) days of its effectiveness. Accordingly, Commission staff attempted to reach the contact person of Visions by telephone. This effort was unsuccessful, indicating that Visions may have also violated Rule 25-24.520(1)(b), Florida Administrative Code, which requires the reporting to the Commission of a change in the name, title, or telephone number of the individual responsible for Commission contacts.

For the reasons described above, pursuant to Rule 25-24.514(1)(b) and (c), Florida Administrative Code, we find it appropriate to cancel Visions's certificate, unless Visions pays a \$500 fine for failure to comply with Section 364.336, Florida Statutes, Rule 25-4.0161, Florida Administrative Code, and remits all past due regulatory assessment fees, along with statutory penalties and interest charges. We also find it appropriate to cancel Visions' certificate unless it pays a \$500 fine for failure to comply with Rule 25-24.480 (2), Florida Administrative Code, and provides the information required by Rule 25-24.520, Florida Administrative Code, to the Florida Public Service Commission. Visions must comply with these requirements within five business days from the date this Order becomes final. The fines will be remitted to the Comptroller for deposit in the State of Florida General Revenue Fund, pursuant to Section 364.516, Florida Statutes.

When the appropriate fees, statutory penalties, interest charges, required information, and fines are received, this docket shall be closed. Should Visions fail to comply with this Order within five business days from the date this Order becomes final, Visions shall have its certificate canceled and the docket will be closed. The cancellation of the certificate and the closing of the

docket in no way diminishes Visions' obligation to pay applicable delinquent regulatory assessment fees, statutory penalties, and interest charges.

Should Visions' certificate be canceled, all certificated local exchange companies are instructed to discontinue service to Visions, pursuant to Rule 25-24.510, Florida Administrative Code, Certificate of Public Convenience and Necessity Required. Any certificated local exchange company providing service to Visions must contact the Commission at the conclusion of the response period indicated herein in order to determine if Visions' certificate has been canceled.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Visions by Lyons Inc. shall pay the past due regulatory assessment fee(s), statutory penalties, interest charges, and a \$500 fine to the Florida Public Service Commission for failure to comply with Section 364.336, Florida Statutes, and Rule 25-4.0161, Florida Administrative Code, within five business days from the date this Order becomes final. The fine will be transmitted to the Comptroller for deposit in the State of Florida General Revenue Fund. It is further

ORDERED that Visions by Lyons Inc. shall provide the correct mailing address, liaison information, and other information in accordance with Rule 25-24.520, Florida Administrative Code, and pay a \$500 fine to the Florida Public Service Commission for failure to comply with Rule 25-24.520, Florida Administrative Code, within five business days from the date this Order becomes final. The fine will be transmitted to the Comptroller for deposit in the State of Florida General Revenue Fund. It is further

ORDERED that should Visions by Lyons Inc. fail to comply with this Order, Visions by Lyons Inc.'s certificate shall be canceled, and the docket shall be closed. It is further

ORDERED that the cancellation of the certificate and the closing of the docket in no way diminishes Visions by Lyons Inc.'s obligation to pay applicable delinquent regulatory assessment fees, statutory penalties, and interest charges. It is further

ORDERED that all certificated local exchange companies shall discontinue service to Visions by Lyons Inc. upon verification of

the cancellation of the certificate at the conclusion of the response period set forth in this Order. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective unless an appropriate petition, in the form provided by Rule 25-22.036, Florida Administrative Code, is received by the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings or Judicial Review" attached hereto. It is further

ORDERED that in the event this Order becomes final, this Docket shall be closed upon payment of the fines, and fees, or upon cancellation of the certificate.
