

Dear Ms. Bayo,

On March 24, 1997, the Commission granted to Digital Services Corporation ("DSC") Certificate No. 4851, authorizing it to provide interexchange ("IXC") service within the State of Florida.¹ On December 22, 1997, the Commission also granted to a DSC affiliate, Teligent, Inc. ("Teligent"), IXC authority.² In response to Question 2 of its IXC application, Teligent represented to the Commission that, upon grant of authority to Teligent, DSC would cancel its IXC certificate. Accordingly, DSC hereby respectfully requests that the Commission cancel its IXC Certificate No. 4851.
