REQUEST FOR CONFIDENTIAL CLASSIFICATION

Supra Telecommunications & Information Systems, Inc.

("Supra" or "Company"), hereby files, pursuant to Rule 25-22.006, Florida Administrative Code, its Request for Confidential Classification, and states the following:

1. Supra is filing a Request for Confidential Classification for the subject information because it is included in Exhibits BH-11, BH-12, BH-13, and BH-14 attached to the Prefiled Direct Testimony of Bradford Hamilton, all of which are being filed this date in this proceeding.

2. Supra is also filing a Request for Confidential Classification for page 39 of Mr. Olukayode A. Ramos' amended prefiled direct testimony filed April 8, 1998. Supra inadvertently included the name of a customer on this page of Mr. Ramos' testimony. Therefore, Supra requests that all copies of page 39 of this testimony be kept confidential and replaced by a redacted copy of Page 39.

3. Supra has appended to this Request for Confidential Classification as Attachment A a listing of the location of the information in Bradford Hamilton's exhibits and the information on page 39 of Mr. Ramos' amended prefiled direct testimony designated by Supra as confidential.

4. Appended hereto as Attachment B are two copies of

Bradford Hamilton's exhibits with the confidential information deleted and two copies of page 39 of Olukayode A. Ramos' amended prefiled direct testimony with the confidential information deleted. Attachment C contains the original exhibits and the original page 39 with the confidential information.

5. The exhibits and page 39 contain information considered to be confidential and proprietary by Supra as Supra is required by Section 364.24, Florida Statutes, to keep this customer specific information confidential. This customer specific information includes customer names, addresses, telephone numbers, and account information. Public disclosure of the customer specific information would violate Section 364.24, Florida Statutes. Therefore, such information should be classified as proprietary, confidential business information pursuant to Section 364.183, Florida Statutes. Accordingly, it should be held exempt from the public disclosure requirements of Section 119.07, Florida Statutes.


6. Supra has treated and intends to continue to treat the information for which confidential classification is sought as private, and this information has not been generally disclosed.
