
MOTION FOR EXTENSION OF TIME

Comes now Amer-I-Net Services Corp. ("Amer-I-Net") through its undersigned and requests an extension of time to respond to Order No. PSC-98-0549-SC-TI issued April 20, 1998. As basis Amer-I-Net would show:

1. Order No. PSC-98-0549-SC-TI is an Order to Show Cause directing Amer-I-Net to show cause why the company should not be fined for apparent violation of PSC rules. The Order requires a written response within 20 days of the date of the order.
2. Amer-I-Net would request that the response be due 60 days from the date of the Order to allow sufficient time to review the complaints and apparent violations and prepare a response. In its Order, the Commission notes that it has received 426 complaints with 176 being apparent violations and the balance either pending response or closure. Absent a review and analysis of all the complaints, Amer-I-Net would not be able to prepare a complete response as required by the Order. Furthermore, the additional time would afford the company and Staff an opportunity to seek resolution of the docket.

Wherefore, for the reasons cited Amer-I-Net respectfully requests that the Commission grant the request for an Extension of Time and that the Response be due 60 days from the date of the Order to Show Cause.


