NOTICE OF APPLICATION
Florida Cities Water Company hereby gives notice of its application to the Florida Public Service Commission to amend its Certificates Nos. 7-W and 3-S to add water and wastewater territory to Brevard County, Florida, pursuant to Section 367.045, Florida Statutes, as follows:

Proposed Extension Area A

The intersection of the North line of the Southeast 1/4 of Section 11 (also the North line of the South 1/2 of Section 31, Township 30 South, Range 30 East) and the westerly right of way line of the Florida East Coast Railroad (100 feet Right of Way width) described the Point of Beginning

run S27°41'2" E along said Westerly Right of Way line for a distance of 2281.57 feet to the South line of the Southeast 1/4 of Section 11, thence S27°41'2" E along said South line for a distance of 470.04 feet; thence departing said South line run N01°12'24" W for a distance of 1252.18 feet; thence N87°24'42" W for a distance of 2071.84 feet; thence N06°27'34" W for a distance of 1081.01 feet to the North line of the South 1/2 of Section 31, Township 30 South, Range 30 East; thence S87°24'42" E along the North line of the South 1/2 of Section 31 for a distance of 1290.88 feet to the Point of Beginning +/-.

Proposed Extension Area B

From the point of commencement of the Northeast corner of Section 15, Township 30 South, Range 30 East, proceed southerly a distance of 134 feet +/-; thence proceed westerly a distance of 1321 feet +/- to the east of Beginning +/-.

From the point of beginning proceed N08°22'13" W a distance of 11.20 feet; thence S87°22'20" W a distance of 226.55 feet; thence N68°32'12" W a distance of 330 feet; thence S87°22'20" W a distance of 322.45 feet; thence S68°22'12" W a distance of 228.80 feet +/-; thence S87°22'20" W a distance of 342.24 feet; thence N68°32'12" W a distance of 311.00 feet; thence S87°22'20" W a distance of 287.74 feet; thence S48°22'42" E a distance of 1790 feet; thence S87°22'20" W a distance of 1335 feet; thence N68°32'12" W a distance of 655.60 feet to the Point of Beginning +/-.
