**RESPONSE AND OPPOSITION TO BELLSOUTH'S  
MOTION TO STRIKE SUPRA'S EXCEPTIONS\OBJECTIONS  
TO STAFF RECOMMENDATIONS (DATED 12/3/98)**

PETITIONER, SUPRA TELECOMMUNICATIONS & INFORMATION SYSTEMS, INC. ("Supra"), by and through its undersigned counsel, hereby files and serves this its response and opposition to BELLSOUTH TELECOMMUNICATIONS, INC.'s ("BellSouth") Motion to Strike Supra's Exceptions\Objections To Staff Recommendations, and in support thereof states as follows:

1. BellSouth has moved to strike Supra's Exceptions\Objections To Staff Recommendations on the grounds that BellSouth does not believe that exceptions are permitted under Rule 25-22.056(4)(b), Florida Administrative Code, when a hearing has been conducted by a panel of commissioners.

2. BellSouth's motion to strike purports to find support under Rule 25-22.037(2)(b), Florida Administrative Code. However, that rule does not provide a basis for striking Supra's Exceptions\Objections To Staff Recommendations. Rule 25-22.037(2)(b) simply governs motions in general and does not authorize or otherwise provide any basis for striking Supra's filing.
