**NOTICE OF COMPLIANCE WITH ORDER SETTING MATTER
FOR HEARING AND REQUIRING RESTORATION OF SERVICE**

This matter originally arose as a result of a complaint submitted on October 2, 1998, on behalf of Atnex Computer Corporation ("Atnex") against BellSouth Telecommunications, Inc. ("BellSouth"). Atnex's complaint concerned termination charges incurred by ComputerEase Associates, which, upon information and belief was formerly under common ownership with Atnex, and was subsequently merged with Atnex. Atnex also complained about the termination of certain other BellSouth services.

At its Agenda Conference of March 16, 1999, the Commission ordered, *inter alia*, that this matter be set for hearing, and that BellSouth restore service to the customer. Order No. PSC-99-0537-PCO-TP (Mar. 23, 1999). In accordance with the Commission's order, Ms. Sherry Coxe of BellSouth contacted Mr. Larry Goodman, Atnex's owner, on March 16 after the Commission had ordered BellSouth to restore Atnex's service. Mr. Goodman told Ms. Coxe that he did not want to have the disconnected services restored. Letter from Sherry A. Coxe to Mr. Larry Goodman dated March 17, 1999 (Attached as Exhibit A). Ms. Coxe assured Mr. Goodman that if he should change his mind prior to the hearing in this matter, BellSouth will expedite his order. *Id.*

By immediately offering to restore Atnex's service, BellSouth believes that it has complied with the portion of the Commission's order requiring it to restore service to Atnex pending the hearing.




