Re: Docket No. 960444-WU - Tariff Sheets and Customer Notice

Dear Mr. Melson:

I have reviewed the proposed revised tariff sheets and proposed customer notice for Docket No. 960444-WS. There are several concerns that need addressing before the tariff sheets are approved. These concerns are as follows:

- 1. Sheet No. 17.0 should be revised to reference the appropriate tariff sheets once staff's concerns, as discussed below, have been met.
- 2. Eighth Revised Sheet No. 18.1, that was submitted, should be Eleventh Revised Sheet No. 18.0. Once this change is made, Sixth Revised Sheet No. 4.0, that was submitted, should then be revised to reference sheet no. 18.0 for general service customers. Then tariff sheet No. 18.1 may be canceled, as discussed in staff concern No. 14, below.

AFA APP CAF CMU	3.	Eleventh Revised Sheet No. 19.0, that was submitted, should reference all meter sizes for residential customers, as approved by the Commission in Order No. PSC-99-0635-FOF-WU.
CTREAG	4.	The charge contained on Fifth Revised Sheet No. 20.0, which is referenced as a "per dwelling unit" charge, was never approved as such; neither by the settlement nor the Commission. If LUSI wants this charge to be addressed, a separate tariff filing should be submitted. Therefore, staff cannot approve this tariff sheet at this time.
WAW	5.	Second Revised Sheet No. 22.1, that was submitted, should be Fourth Revised Sheet 22.0. Then tariff sheet No. 22.1 may be canceled, as discussed in staff concern No. 14, below.

- 6. First Revised Sheet No. 22.2-A, on file with the Commission should be revised to First Revised Sheet No. 22.1. Then sheet No. 22.2 may be canceled, as discussed in staff's concern No. 14, below.
- 7. Second Revised Sheet No. 25.1, that was submitted, should become Sixth Revised Sheet No. 25.0.
- 8. Third Revised Sheet No. 25.1-A that was submitted should become Second Revised Sheet No. 25.1. The remaining sheets should be canceled as addressed in staff's concern No. 14, below.
- 9. Guaranteed Revenues, as referenced on Fifth Revised Sheet No. 27.4 are no longer appropriate. Currently, there are no guaranteed revenues approved for LUSI.
- 10. First Revised Sheet No. 30.0 has been submitted which leaves this tariff sheet blank. What about tariff sheet Nos. 30.1 and 30.2? Should these sheets be canceled?
- 11. First Revised Sheet No. 31.0 has been submitted which leaves this tariff sheet blank. What about tariff sheet Nos. 31.01 through 31.15? Should these sheets be canceled?
- 12. First Revised Sheet No. 33.0, that was submitted, should reflect the appropriate revision number of Second Revised Sheet No. 33.0. The remaining sheets should be canceled as addressed in staff's concern No. 14, below.
- 13. Original Sheet No. 38.0 references a \$3.00 service fee. This fee is not contained in the rates and charges portion of your tariff. Please provide the Commission's order number where this charge was approved. If this charge has been approved by the Commission, submit the appropriate revised tariff sheet with this charge included. If this charge has not been approved, remove this charge from your application and from tariff sheet No. 38.0
- 14. To eliminate excess blank pages, staff would propose to cancel the following tariff pages once the above changes have been made:

In addition, staff believes that the disposition of interim revenues should be addressed in the customer notice. The customers should receive notice that interim revenues will be refunded. Further, please include the following language:
