short-term securities during the calendar years 2000 and 2001 in an amount or amounts such that the aggregate principal amount of short-term securities outstanding at the time of the sale will not exceed 25% of FPL's gross revenues during the preceding twelve months of operation.

Recommendation: The Commission should approve the action requested in the dockets referenced above and close these dockets, with the exception of Dockets Nos. 991139-EI, 991287-EI, and 991337-GU, which must remain open until March 15, 2001, April 15, 2001, and February 15, 2001, respectively, to allow each company to file the required Consummation Report.
