

COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth" or "Company"), and files its Notice of Intent to request a temporary waiver of the collocation requirements in the Holly-Navarre central office pursuant to Order No. PSC-99-1744-PAA-TP issued September 7, 1999.

1. BellSouth is unable to provide collocation in this office due to the lack of space. Currently, BellSouth has plans to complete a building addition in this office sometime in the fourth quarter of 2000. 5. A copy of this notice has been sent to the applicant for space.


