<u>Recommendation</u>: The Commission should approve the negotiated agreements and amendments to agreements, except for those provisions set forth in the analysis portion of staff's December 9, 1999 memorandum that discriminate against telecommunications carriers not a party to the agreements. Staff believes the implementation of the agreements as written is not consistent with the public interest and violates Section 252(i) of the Telecommunications Act of 1996.
