Staff is in receipt of SMBR's request for cancellation of pay telephone certificate no. 5597. However, staff cannot process its request at this time. On June 17, 1999, staff opened Docket No. 990781-TC to investigate apparent pay telephone service violations. On August 11, 1999, Order No. PSC-99-1580-SC-TC was issued ordering SMBR to show cause why it should not be fined or have its certificate canceled for apparent pay telephone service violations and delinquent regulatory assessment fees. If staff does not receive a response by the close of business on September 1, 1999, SMBR's certificate will be canceled and the delinquent regulatory assessment fees will be forwarded to the Comptroller's Office for collection.
