RE: DOCKET NO. 981993-WS - APPLICATION FOR NAME CHANGE ON CERTIFICATE NOS. 514-W AND 446-S IN BAY COUNTY FROM SANDY CREEK UTILITIES, INC. TO FOX-RUN UTILITIES, INC.

On December 29, 1998, Mr. Gary L. Souders filed an application for a name change on Certificates Nos. 514-W and 446-S from Sandy Creek Utilities, Inc. to Fox-Run Utilities, Inc. Subsequent to the date of filing, the Commission staff sent a letter outlining the deficiencies in the application. One of the deficiencies listed was that the new name had not been registered with the office of the Secretary of State.

Mr. Souders has decided to wait until the utility transfer has actually taken place prior to incurring the expense associated with pursuing the name change. By letter dated January 5, 2000 (attached), Mr. Souders requested to withdraw the application for name change filed on December 29, 1998. The request was filed on behalf of Sandy Creek Utilities, Inc. Since the name of the utility was never changed and no further action is necessary, the docket should be closed.

Upon joint recommendation of the OER Division and the Division of Legal Services, Section 2.07-2(C)(6)(d) of the Administrative Procedures Manual grants the Division of Records and Reporting the authority to administratively close dockets in which the applicant seeks to withdraw its initial pleading. As stated previously, the application has been withdrawn. Further, there are no pending issues that need to be addressed by the Commission regarding this filing, there is no filing fee involved, and no agency action needs to be taken. Therefore, this docket may be closed.
