**GTE FLORIDA INCORPORATED'S
REQUEST FOR CONFIDENTIAL CLASSIFICATION AND
MOTION FOR PERMANENT PROTECTIVE ORDER**

GTE Florida Incorporated (GTE) asks the Commission to grant confidential classification and a permanent protective order for certain information produced to Staff in connection with its audit of GTE's affiliate relationships. All of this information for which GTE seeks confidential classification falls within Florida Statutes §364.183(3)(e), which defines the term "proprietary confidential business information" to include "information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of that information." The specific documents for which GTE seeks confidential protection are:

1. GTE Financial Policy and Standard Practice, J-301. This document sets forth the basis for prorating expenses of GTE Service Corporation among GTE affiliates. GTE's internal policies, including this one, are considered confidential by the Company and are not publicly disclosed. Knowledge of GTE's internal finance procedures could give competitors valuable information about ways to structure their own businesses, or about GTE's potential vulnerabilities, without the usual market trial and error.

2. Miscellaneous Billing Requisition General Instructions, Practice 003-106-000. This document contains instructions for GTE personnel to initiate, adjust, or correct miscellaneous billings. Again, it is an internal GTE document that is kept confidential by



the Company and not publicly disclosed. Information about GTE's administrative procedures could provide competitors valuable information about ways to structure their own businesses, or about GTE's potential vulnerabilities, without the usual market trial and error.

3. Billing and Collection Services, Summary of Purchase Order Charges Billed by GTEDS on Behalf of GTE Florida for Invoices Dates 12/01/95. This document contains specific information about invoices issued to various telecommunications companies by GTE Data Services on GTE Florida's behalf. It includes specific company names and invoice amounts, along with purchase order information. This information is considered confidential by both GTE and the companies billed for the services at issues. Public disclosure of amounts paid for various services could interfere with these companies' negotiations for similar service with other entities. In a competitive marketplace, contract prices and payments made to other companies are not typically disclosed publicly.

In a competitive business, any knowledge obtained about a competitor can be used to the detriment of the entity to which it pertains, often in ways that cannot be fully anticipated. This unfair advantage skews the operation of the market, to the ultimate detriment of the telecommunications consumer. While a ruling on this request is pending, GTE understands that the information at issue is exempt from Florida Statutes, Section 119.01(1) and Staff will accord it the stringent protection from disclosure required by Rule 25-22.006(3)(d). One highlighted, unredacted copy of the confidential material, labeled Exhibit A, is attached to the original of this Request. Redacted copies of these items are attached to this Request as Exhibit B.

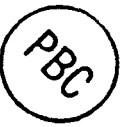


