Dear Paula and Kimberly:

I am enclosing copies of the materials that I discussed with Paula on December 21, 1999. They include a copy of the Assessment Fee Report for 1998 that Qwest prepared on February 1, 1999, and a copy of the UPS Tracking Report that indicates that it was received in the Commission's mail room on February 3, 1999.

Qwest has been unable to locate proof that a check for the 1998 Regulatory Assessment Fees accompanied the report. Qwest assumes an administrative error on its end led to the check request being separated from the report. Qwest is prepared to pay the fees with interest. Our purpose in bringing the materials to Staff's attention is to demonstrate Qwest's attempt to comply with the Commission's requirements. We hope the Commission will conclude that no penalty is warranted under the circumstances.
