Dear Ms. Bayo:

On behalf of UniDial Telecommunications LLC ("Uni-Tel" or "Company"), this letter is to notify the Florida Public Service Commission ("Commission") of the Company's intention to change its name to Lightyear Telecommunications LLC. A copy of the Amended Certificate of Authority to Transact Business in the State of Florida is attached hereto as Exhibit A.

By way of background, Uni-Tel is authorized to provide interexchange telecommunications services in the State of Florida pursuant to Certificate No. 3960 issued by Commission Order No. PSC-94-1549-FOF-TI in Docket No. 940923-TI, on January 5, 1995.<sup>1</sup> Including Florida, Uni-Tel is authorized to provide resold intrastate interexchange and/or local exchange telecommunications services in 38 states, pursuant to certification, registration, or (where appropriate) deregulation. Uni-Tel is also authorized by the Federal Communications Commission ("FCC") to provide resold and facilities-based international message telecommunications services between the United States and various international points.

Uni-Tel has determined that the name change from UniDial Telecommunications LLC to Lightyear Telecommunications LLC will be a valuable step in developing the Company's telecommunications services and in implementing its ongoing business plan. The name change will
