Intermedia Communications, Inc. ("Intermedia"), by its undersigned counsel, hereby respectfully submits this letter in lieu of a formal reply, in response to BellSouth Telecommunications, Inc.'s ("BellSouth") "Emergency Motion to Compel", which was filed on July 11, 2000.

Intermedia advises the Commission that, pursuant to an agreement with BellSouth on July 11, it has agreed to provide a response to BellSouth's interrogatories which seek information concerning the economic or useful lives of Intermedia's cable and switches used to provide telephone exchange service in Florida (Interrogatory Nos. 7 and 10). Similarly, Intermedia has agreed to produce documents relating to the economic lives of Intermedia's cable and switches (Production Request Nos. 1 and 2), to the extent responsive documents are available. In turn, BellSouth has agreed to immediately withdraw its motion to compel against Intermedia.
