Through Ms. Isler, I was informed of my obligation for filing an annual return for our pay telephone certificate. I apologize for not filing in a timely manner.

This is the first year for Southern Telecom Communications, Inc. certification. Although the company does not own any pay telephones, I applied for the certificate in anticipation that my company may enter this business in the future. I was unaware of our obligation to file, and was unaware of a tax form sent to me last December, as Ms. Isler indicated in our telephone conversation.

I appreciate her guidance. We have noted on the company calendar to expect the annual form each December. I have also enclosed a check for sixty-six dollars and fifty cents (\$66.50 - \$50.00 fee+\$12.50 penalty, and \$4.00 interest).

In regards to a settlement amount, I would like you to consider not assessing an additional amount beyond the penalty.
