Dear Mrs. Bayo:

The above-referenced docket was initiated because MediaOne Florida Telecommunications, Inc.'s failed to file its 1999 alternative local exchange company regulatory assessment fee form. As you know, on September 21, 1999 this Commission granted transfer of control of MediaOne to AT&T Communications of the Southern States, Inc. (AT&T.) Since that time, both companies have been working to coordinate their respective functions. Unfortunately, it appears that the MediaOne regulatory assessment fee return was overlooked.

On October 16, 2000, the company paid its regulatory assessment fee to the Commission, including penalty and interest charges for late payment. A copy of the ALEC RAF Return and payment are attached.

MediaOne and AT&T would like to advise the Commission that a procedure for timely filings of regulatory assessment fee returns has been instituted which will prevent late payments in the future. We understand that the Commission has the authority to impose a fine for late payment, and we would like to offer \$100 in settlement. We have researched other cases in which companies neglected to pay regulatory assessment fees, and it appears that this amount typically is acceptable. We understand that payment of the settlement amount is due within 10 business days after the Commission's order of approval.
