Attached is proof of the company's authorization to transact business in Florida under this name by the Secretary of State. The company has also requested that the word EPIC be in all capital letters.

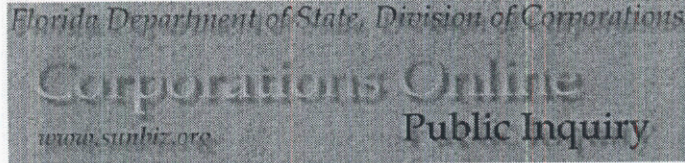
The name change should be corrected in the docket title, MCD, and the utilities and parties of record listed in CMS.

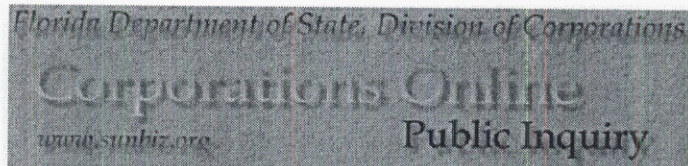
