Thank you for your letter dated April 7, 2003, (copy attached) regarding the transfer of Pennbrooke Utilities, Inc. to Utilities of Pennbrooke, Inc. (Pennbrooke or utility). Your concern is low water pressure in the water distribution system. According to Rule 62-555.320(7), Florida Administrative Code, "High Service Pumps - High service pumping and distribution facilities shall be designed to provide maximum hourly system demand without either development of a distribution pressure lower than 20 psi or other health hazards..." We have contacted Ms. Karen Milicic, inspector of the Pennbrooke's water facility for the Florida Department of Environmental Protection, at (407) 894-7555 Ext 2226 to investigate the low pressure issue and advise staff of her findings.

In addition, Mr. Martin S. Friedman, attorney for the utility has requested that the utility investigate the problem. Once we receive the responses from the investigation, staff will determine what action, if any is needed.
