The above agreement is an "Amendment No. One" to 020669-TP. The transmittal letter from Sprint-Florida states it is an amendment to the IURC filed in 020669-TP but the underlying agreement was only for "interconnection, unbundling, and resale", and collocation wasn't included. (A master collocation agreement between the two companies was filed later, in 021180-TP).

Since this agreement appears to be an amendment to the first docket, and the recitals do not contain "collocation", it appears the letter should not include the collocation element. If it *should* include the collocation element, I believe the letter should also mention the 021180-TP.

Can you please clarify whether both dockets should be mentioned or if collocation should be removed?
