

SECTION 2 - REGULATIONS

2.1 Undertaking of the Company

- 2.1.1 Service is furnished for telecommunications originating and terminating within the State of Florida under the terms and conditions of this price list.
- 2.1.2 UStel's voice services will involve the resale of the basic local exchange services of the incumbent local exchange telephone companies.
- 2.1.3 Carrier's services are available for use twenty-four hours per day, seven days per week.

2.2 Use of Services

- 2.2.1 Carrier's services may be used for any lawful purpose consistent with the transmission and switching parameters of the telecommunications facilities utilized in the provision of services.
- 2.2.2 The use of Carrier's services without payment for service or attempting to avoid payment for service by fraudulent means or devices, schemes, false or invalid numbers, or false calling or credit cards is prohibited.
- 2.2.3 The Carrier does not transmit messages pursuant to this price list, but its services may be used for that purpose.
- 2.2.4 The Carrier's services may be canceled for nonpayment of uncontested bill charges or for other violations of this price list.
- 2.2.5 This service is voice applications. The Company reserves the right to adjust a customer's service upon appropriate customer notification. If it is determined that usage is not consistent with voice applications, customers' service may be assessed a \$50 monthly recurring data usage charge or disconnected.

3.6.6 Member to Member

Member to Member Service is available to all USTel Customers of a Network Exchange Bundled Service. Member to Member allows USTel Customers to call other USTel Customers without incurring per call usage charges or depleting the bundled minutes call allowance up to the limit specified below. Calls under the Member to Member option must originate on and terminate to a telephone number presubscribed to a USTel Network Exchange Bundled Service. Customers are not required to identify Customers in their calling circle. Such identification will be handled by the Company's network.
