

The City of North Miami Senior Citizens Advisory Board supports the City's representatives appearing before the Florida Public Service Commission (PSC) on Monday, February 5, 2007.

The Senior Citizens Advisory Board opposes Florida Power & Light's (FPL) proposed tree-trimming service schedule of six (6) years. A 3-year tree trimming schedule would better serve our seniors. There are still North Dade County residents dealing with Hurricane Wilma's tree debris issues. Medically needy elders were placed at extreme risk due to lack of tree-trimming issues, transfer pots and lines, and pole maintenance. Weeks of power outages affect the health and welfare of senior citizens, who are unable to refrigerate medicines and do other tasks of daily living.
