

### Case Background

Enhanced Billing Services, Incorporated (Enhanced Billing), Access Communications, Inc. (Access One), and Toll Free Connect, Inc. (Toll Free), registered with the Commission as intrastate interexchange telecommunications companies (IXCs) on July 23, 2004, August 18, 2004, and August 25, 2005, respectively. They were assigned IXC Registration Nos. TJ938, TJ942, and TK018, respectively. Collectively, the three companies are referred to as "Group" in this recommendation where appropriate to simplify the discussion.
