On June 5, 2007, you contacted me concerning a customer complaint that was filed with the Commission against your company regarding the "Nation's Choice" prepaid calling card. After our telephone conversation, I faxed a copy of the complaint to you and requested that you respond by June 8, 2007. To date, I have not received a response. I have enclosed a copy of the information that was faxed to you on June 5, 2007. Please investigate the complaint, contact the customer, and provide a written response to the complaint. Your response should verify that the customer was contacted and that the complaint was resolved. Please submit your response no later than October 2, 2007. You may fax your response to me at (850) 413-6663 or you may respond by email to kcurry@psc.state.fl.us.

Also, during our telephone conversation you stated that your company, Reliable Telecard, was registered with the Commission as an interexchange telecommunications (IXC) company and was therefore authorized to provide prepaid calling card services in Florida. Furthermore, you stated that Reliable Telecard also operated under the names Ntera, Inc. (CLEC Certificate No. 7922) and Radiant Telecom, Inc. However, as I informed you during our conversation, I was unable to confirm that Reliable Telecard was indeed registered as an IXC with the Commission. In addition, our records also indicate that Ntera, Inc.'s CLEC certificate and Radiant Telecom, Inc.'s IXC registration were both cancelled in 2005. Therefore, neither company is authorized to provide telecommunications services in Florida. However, as I informed you, I was able to confirm that Ntera, Inc. is registered with the Commission as an IXC.

Since our last conversation, staff has determined that Reliable Telecard may also be operating under the names NCOM Network, LLC and TEL3. According to our records, both NCOM Network, LLC and TEL3 are not authorized to provide telecommunications services in Florida. TEL3's IXC registration and CLEC certificate were both cancelled in 1999. Because Reliable Telecard d/b/a Radiant Telecom, Inc. d/b/a NCOM Network, LLC d/b/a TEL3 provides

prepaid calling card services in Florida, the company will need to register and file a tariff with the Commission.

Rule 25-24.470(1), Registration Required, Florida Administrative Code, states:

No person shall provide intrastate interexchange telephone service without first filing an initial tariff containing the rates, terms, and conditions of service and providing the company's current contact information with the Division of the Commission Clerk and Administrative Services.

After you have completed the enclosed IXC Registration form, please submit it along with the company's tariff to the following address by October 2, 2007:

Please understand that if Reliable Telecard fails to respond to the Commission that it may be subject to penalties as prescribed by Section 364.285, Florida Statutes, which states:

> The commission shall have the power to impose upon any entity subject to its jurisdiction under this chapter which is found to have refused to comply with or to have willfully violated any lawful rule or order of the commission or any provision of this chapter a penalty for each offense of not more that \$25,000, which penalty shall be fixed, imposed, and collected by the commission; or the commission may, for any such violation, amend, suspend, or revoke any certificate used by it. Each day that such refusal or violation continues constitutes a separate offense.

Therefore, to avoid potential penalties please submit all of the requested information no later than October 2, 2007. If you have any questions, you may contact me at 850-413-6662.
