

Let me introduce myself, I am a retired Bank Executive of 35 years. I spent a large part of my career as a Commercial Loan Officer before going into management. As a Commercial Loan Officer I dealt with large and small businesses looking to expand their business for better profitability.

These businesses had to raise capital for this expansion. Their options were to raise capital by acquiring new investors or borrowing the necessary funds, assuming they had already streamlined the company to its highest efficiency.

These businesses did not have the ability to go to their customer base and charge an addition fee for future expansion that is to occur 10 plus years from now with no return for their investment

We are being forced to invest in your company for a minimum of the next ten years with no return on our investment and if the plant is never built for a myriad of reasons you do not have to return the investment. This sounds like a very sweet deal to me.

This plant will most likely never benefit me and great number of the customer base during our life expectancies by the time the plant goes on line ten plus years from now.

You have picked a terrible time to ask for this fee plus a rate hike equaling about a 25% increase in our electric bills when we are in the direst economical times since the GREAT DEPRESSION in the 1930's. Other Utility Companies are lowering their rates and paying their investors a nice dividend during this economic recession.

This is to acknowledge receipt of your letter to Chairman Matthew M. Carter II, Florida Public Service Commission, regarding Progress Energy Florida, Incorporated (Progress Energy). Given the nature of your concerns, Chairman Carter feels it would be appropriate for specialized staff of the Division of Service, Safety and Consumer Assistance to respond directly to you.

You expressed a concern about fuel adjustment charges. Fuel adjustment charges allow the utility to recover the actual expenses associated with securing and processing fuel necessary to run the power plants used to generate electricity. Fuel rates mirror rising and falling fuel costs as reflected in the international marketplace. The revenue generated by the fuel adjustment charge does not add to the profit of the utility companies, but goes to pay fuel suppliers and transporters. The cost of fuel is shown as a separate cents per kilowatt-hour charge, and fuel costs are not contained in any other charge on your bill.

Each year, utilities file their projected fuel expenses for the upcoming calendar year. The PSC, along with the Office of Public Counsel and other consumer representatives closely examine the fuel costs requested by the utilities. Public hearings are held annually to set the fuel factors for the next year. Since rates are set on projected costs, at the end of the year, the costs are "trued-up" or compared to the audited actual expenses incurred by the utility. If the utility recovered more than its actual costs, the amount of over-recovery is used to reduce the next year's costs. If the utility under-recovered (costs were higher than expected) that deficit is likewise rolled into the next year. The fuel cost adjustment is recognized by virtually all state commissions, by the Federal Energy Regulatory Commission, and is also used by most municipal electric utilities and rural electric cooperatives.

On November 13, 2008, the PSC set the 2009 fuel adjustment charges for the customers of Florida investor-owned electric utilities. The fuel adjustment charges were decided at a hearing where the Commission considered each utility's projected costs of fuel and the purchased power for 2009 as well as 'trued up' costs for 2008.

You also expressed a concern about Progress Energy's petition to recover prudently incurred preconstruction costs associated with nuclear power plants. Upon PSC approval of a

utility's need for a nuclear plant upgrade or new plant construction, the utility can petition for cost recovery under the new Commission rule adopted in February 2007. The PSC held the first annual nuclear cost recovery evidentiary hearings on September 11 and 12, 2008, where commissioners heard testimony from utility companies, consumer groups, and the public.

On October 14, 2008, the PSC approved cost recovery amounts covering construction of proposed new nuclear plants and upgrades to existing nuclear plants for Progress Energy. Costs will be recovered from customers through the capacity cost recovery charge on their bills beginning in January 2009. The PSC's decision was based on evidence developed during the September 11, and 12, 2008 nuclear cost recovery hearings.

The uprate of the existing Crystal River nuclear plant and the proposed new nuclear facility in Levy County will add 2,380 megawatts of new nuclear base load generation to Progress Energy's system. The new nuclear Levy Units 1 & 2 are expected to come online in 2016 and 2017 and will also power about one million average-sized residential homes using 1,200 kilowatts per month.

As a result of the November hearings, a residential customer using 1000 kWh will see their bill increase from \$110.59 to \$137.87, an increase of 24.67%. While it is expected that bills will continue to increase as construction of the nuclear plants progresses over the next 10 years, Progress Energy customers will see significantly lower fuel costs once those plants are placed in service. The Commission will continue to examine utility requests for rate increases in order to ensure that only those costs that are prudently incurred will be included in rates.

Complaints serve as a valuable source of information; therefore, your complaint will remain on file with the PSC. We monitor complaints very closely and track any trends which indicate there may be a problem and further action is needed.

Dear Governor Crist:

First I would like to congratulate you on your recent marriage.

Now, down to business. I have been corresponding for several months with your website, but all that happens is they lead me to someone else. Hense the reason for this letter.

The issue is Progress Energy, their obsorbent rates, and expansion of nuclear facilities. The expansion of the Crystal River plant endangers some of Florida's most prestine water sources. The area has great Manatee preserves that are warm springs water fed, and so with Weiki Wachi. An accident there would endanger some of our most precious water resources. The other plant they are advocating is in an area equally ridiculous. Florida has had 0 population growth the past year. What there reason for this expansion is beyond any reason! Not only is it not necessary, we need to use Floridas free resources to generate power, not use Nuclear Energy.

I'm sure hou are aware of the 268-page Navigant Consulting Report to fix the scope and speed of Florida's push toward renewable energy. I won't go into detail of the reports findings, but the lack of use of renewable energy is shamefull. The report says that by 2020, Florida's renewable energy capacity could reach 174,000 megawatts – 116 times the state's renewable energy capacity today. By 2020, solar and wind could produce more than 330 terawatt hours – more than all the power produced in Florida last year.

Are you aware of the 2 garbage mountains in Central Florida? There's one off of 75 near Tampa, and another one off the Florida Turnpike. These hills are several hundreds of feet high. The garbage is free, and the supply inexaustable. Those 2 hills, if facilities were set up like the one in Lee County, could supply enough energy for their local areas - and no cost for the fuel – and help keep our beautiful landscapes without those eyesores, and the obnoxious odor they cause.

Also, the report states that solar and wind energy are also the best "free" resources for Florida.

Progress Energy now uses "ridiculous" fuel costs. This is the "computer age". They don't need to set a fuel rate for 12 months. The rates could be easily adjusted monthly on your bills. This "futures" buying of fuel is not acceptable.

Below I'm listing the rates I paid for their service during 2008, and their "fuel costs" which have not gone down along with the 50% reduction in energy costs since June of this year. In fact, they raised the cost of fuel in August on the first 1000 KWH. In addition, they are raising our rates 25% to \$27.28 for a residential 1000 killowatt-hours, \$14.09 for fuel costs, and \$11.42 for the new nuclear-plant construction in Levy County, and \$.69 for the Levy Plant, etc., etc. We are asked to fund their plant construction. Utilities are supposed to be issuing stocks and bonds for that expansion purpose. We're paying but they are not issuing us "STOCK" for paying for these facilities – THEY SHOULD BE. But most of all, they should not be building nuclear. There is still no way of getting rid of nuclear waste safely. This increase in our monthly bills will wipe out the Social Securing increase for myself for 2009.

We've done everything possible to conserve energy. Double windows, insulated ceilings and walls, airconditioning only to 80 degrees, and heating to 70 degrees, turned the pool to run only 4 hours instead of 8, use only low watt use light bulbs, converted appliances to propane, but instead of getting ahead of the game, we loose from increased costs. We can't do more unless we just "quit using electricity altogether".

Please Governor, stop the nuclear plant expansions and new facilities and force Progress Energy to use the resources I listed above if they need more power (which I sincerely doubt).

The Governor's office forwarded a copy of your correspondence regarding Progress Energy Florida, Incorporated (Progress Energy) to the Florida Public Service Commission (PSC). The PSC regulates investor-owned electric, natural gas, and telecommunications utilities throughout Florida, and investor-owned water and wastewater utilities in those counties which have opted to transfer jurisdiction to the PSC.

You expressed a concern about fuel adjustment charges. Fuel adjustment charges allow the utility to recover the actual expenses associated with securing and processing fuel necessary to run the power plants used to generate electricity. Fuel rates mirror rising and falling fuel costs as reflected in the international marketplace. The revenue generated by the fuel adjustment charge does not add to the profit of the utility companies, but goes to pay fuel suppliers and transporters. The cost of fuel is shown as a separate cents per kilowatt-hour charge, and fuel costs are not contained in any other charge on your bill.

Each year, utilities file their projected fuel expenses for the upcoming calendar year. The PSC, along with the Office of Public Counsel and other consumer representatives closely examine the fuel costs requested by the utilities. Public hearings are held annually to set the fuel factors for the next year. Since rates are set on projected costs, at the end of the year, the costs are "trued-up" or compared to the audited actual expenses incurred by the utility. If the utility recovered more than its actual costs, the amount of over-recovery is used to reduce the next year's costs. If the utility under-recovered (costs were higher than expected) that deficit is likewise rolled into the next year. The fuel cost adjustment is recognized by virtually all state commissions, by the Federal Energy Regulatory Commission, and is also used by most municipal electric utilities and rural electric cooperatives.

On November 13, 2008, the PSC set the 2009 fuel adjustment charges for the customers of Florida investor-owned electric utilities. The fuel adjustment charges were decided at a hearing where the Commission considered each utility's projected costs of fuel and the purchased power for 2009 as well as 'trued up' costs for 2008.

You also expressed a concern about Progress Energy's petition to recover prudently incurred preconstruction costs associated with nuclear power plants. Upon PSC approval of a utility's need for a nuclear plant upgrade or new plant construction, the utility can petition for cost recovery under the new Commission rule adopted in February 2007. The PSC held the first annual nuclear cost recovery evidentiary hearings on September 11 and 12, 2008, where commissioners heard testimony from utility companies, consumer groups, and the public.

On October 14, 2008, the PSC approved cost recovery amounts covering construction of proposed new nuclear plants and upgrades to existing nuclear plants for Progress Energy. Costs will be recovered from customers through the capacity cost recovery charge on their bills beginning in January 2009. The PSC's decision was based on evidence developed during the September 11, and 12, 2008 nuclear cost recovery hearings.

The uprate of the existing Crystal River nuclear plant and the proposed new nuclear facility in Levy County will add 2,380 megawatts of new nuclear base load generation to Progress Energy's system. The new nuclear Levy Units 1 & 2 are expected to come online in 2016 and 2017 and will also power about one million average-sized residential homes using 1,200 kilowatts per month.

As a result of the November hearings, a residential customer using 1000 kWh will see their bill increase from \$110.59 to \$137.87, an increase of 24.67%. While it is expected that bills will continue to increase as construction of the nuclear plants progresses over the next 10 years, Progress Energy customers will see significantly lower fuel costs once those plants are placed in service. The Commission will continue to examine utility requests for rate increases in order to ensure that only those costs that are prudently incurred will be included in rates.

Complaints serve as a valuable source of information; therefore, your complaint will remain on file with the PSC. We monitor complaints very closely and track any trends which indicate there may be a problem and further action is needed.

First I would like to congratulate you on your recent marriage.

In fact, they raised the cost of fuel in August on the first 1000 KWH. In addition, they are raising our rates 25% to \$27.28 for a residential 1000 killowatt-hours, \$14.09 for fuel costs, and \$11.42 for the new nuclear-plant construction in Levy County, and \$.69 for the Levy Plant, etc., etc. We are asked to fund their plant construction. Utilities are supposed to be issuing stocks and bonds for that expansion purpose. We're paying but they are not issuing us "STOCK" for paying for these facilities – THEY SHOULD BE. But most of all, they should not be building nuclear. There is still no way of getting rid of nuclear waste safely. This increase in our monthly bills will wipe out the Social Securing increase for myself for 2009.

The PSC regulates investor-owned electric, natural gas, and telecommunications utilities throughout Florida, and investor-owned water and wastewater utilities in those counties which have opted to transfer jurisdiction to the PSC.

There are a number of factors that go into setting fuel cost adjustments for electric utilities. Because fuel prices tend to be volatile, utilities are permitted to recover the cost of the fuel used to generate electricity through a fuel adjustment charge, also known as the fuel cost recovery clause. The Commission holds annual hearings each November to set fuel rates for the following year. Consumer interests are represented at these hearings by attorneys with the Office of Public Counsel. During the hearings, the Commission examines fuel price projections for the following year, and identifies any over or under-recovery of fuel costs for the current and previous years. The objective is to set rates that allow the utility to collect only the fuel costs it actually incurs.

The level of a utility's fuel costs is largely dependent upon the mix of fuels utilized to generate electricity, and the changing market conditions for each of those types of fuel. However, even if a utility has a fuel mix with heavy reliance on oil, the utility's fuel costs may not immediately decline when the price of oil declines. In order to ensure a stable supply of reasonably priced fuel, utilities enter into multi-year contracts for the purchase of approximately 50% of their fuel. While these contracts limit the utilities' ability to respond quickly to fuel price declines, they also protect consumers from fuel price increases during the term of the contract.

Progress Energy's generation fuel mix is approximately 50% natural gas, 33% coal, 13% nuclear, and 4% oil. Even if Progress Energy were buying all of its fuel on the spot market and had no multi-year fuel contracts, the lower oil prices would not significantly affect its fuel costs.

During the November hearings, the Commission considered Progress Energy's actual and projected fuel costs, and approved an increase in their fuel rate for 2009 of \$14.09 per 1000 kWh of residential usage. This rate includes an under-recovery of fuel costs from 2008.

In setting rates for 2010, the Commission will determine whether Progress Energy collected more revenues during 2009 than it incurred in costs. If that occurs, the over-recovery will be refunded to customers with interest. To aid in that assessment, the Commission has ordered Progress Energy to file a report in early March that will provide new estimates of their fuel costs compared to the revenues generated by the rates the Commission just approved. All utilities are required to notify the Commission at any point during the year if it appears their fuel rates will result in an over or under-recovery by more than 10%. At that time the Commission can require rates be re-adjusted to align with costs.

In addition to fuel costs, utilities are permitted to recover other specific costs through recovery clauses. The environmental cost recovery clause allows utilities to recover the cost of complying with environmental regulations or requirements. The Commission approved an increase of \$2.50 to recover the cost of Progress

Energy projects that will reduce sulfur and nitrogen oxide emissions. In addition, the Commission approved an increase of \$9.74 over their 2008 capacity cost recovery charge, largely due to Progress Energy's preconstruction costs associated with the planned nuclear plant construction projects.

As a result of the November hearings, a residential customer using 1000 kWh will see their bill increase from \$110.59 to \$137.87, an increase of 24.67%. While it is expected that bills will continue to increase as construction of the nuclear plants progresses over the next 10 years, Progress Energy customers will see significantly lower fuel costs once those plants are placed in service.
