

Dear Ms. Bayo:

Americatel Corporation ("Americatel") and Startec Global Operating Company ("Startec") (collectively, the "Companies"), by their attorneys pursuant to the Rules of the Division of the Commission Clerk and Administrative Services Florida Public Service Commission (the "Commission"), advise the Commission that on December 31, 2007, they concluded a transaction resulting in a pro forma transfer of control of Startec, a provider of resold interexchange telecommunications services in Florida (the "Transaction"). The Companies previously submitted notification of their intention to execute this Transaction in a letter dated November 28, 2007.<sup>2</sup>
