Gulf Power Company ["Gulf Power", "Gulf", or "the Company"], by and through its undersigned attorneys and pursuant to Rule 25-22.006, Florida Administrative Code, hereby gives notice that it intends to request confidential classification for portions of Gulf Power's response to Staff's First Set of Interrogatories to Gulf Power Company (Nos. 1-10). Copies of the confidential documents are attached hereto as Exhibit "A".


