1. NEFCOM currently possesses a certificate of public convenience and necessity for pay telephone service ("PATS certificate") pursuant to Section 364.337 Florida Statutes and Rule 25-24.510 F.A.C. The company code is TG053.
2. NEFCOM is no longer deriving revenues from its pay telephone business and therefore requests cancellation of its PATS certificate.
3. Pursuant to Rule 25-24.515(2)(a), F.A.C., enclosed herewith is NEFCOM's 2008 regulatory assessment fee form and applicable fee.


WHEREFORE, NEFCOM respectfully requests that its PATS certificate be canceled.
