In accordance with Appendix F of the Service Quality Measurements Plan, BellSouth Telecommunications, Inc., d/b/a AT&T Florida ("AT&T Florida") herewith files its Proposed Data Notification Report for May 2008 data month. There are no changes for the May Proposed Data Notification Report. Therefore, the industry call scheduled for April 7, 2008 has been cancelled.

AT&T Florida would like to clarify one additional matter for the Commission and the parties. In its March 3, 2008 filing of the May 2008 Preliminary Data Notification Report, AT&T Florida stated that it provided notice on June 1, 2007 that it would modify PMAP to capture the latest version of the LSR for orders by performing additional lookups. Although AT&T Florida expected to make the change with August 2007 data, it was to be implemented with February 2008 data instead. Since AT&T Florida's March 3, 2008 filing, this modification has been completed.

## PROPOSED MAY 2008 DATA NOTIFICATION

BellSouth Telecommunications, Inc., d/b/a AT&T Florida ("AT&T Florida") provides Data Notifications each month in compliance with the SQM Plan. The SQM specifies that when AT&T Florida proposes making any changes to the methods by which performance data is calculated, it must provide written notice. This notice must be provided on the first business day of the month before the data month in which the change will be made. AT&T Florida must also provide notification if it is considering making changes to the method of calculating data for the following month.

ENCORE Releases may affect monthly data flows from the source systems (e.g., LEO, LESOG, etc.) that PMAP uses to calculate measurements. AT&T Florida will make changes to PMAP to ensure that data continues to be correctly captured as ENCORE Releases are implemented.

System releases related to the merger between BellSouth and AT&T may affect monthly data flows from the source systems that PMAP uses to calculate measurements. AT&T Florida will make changes to PMAP to ensure that data will be correctly captured as system changes are implemented.


