By letter received February 28, 2008, Quincy Telephone Company d/b/a TDS Telecom/Quincy Telephone filed a request for approval of the first amendment to the wireless interconnection agreement with Sprint Spectrum L.P., NPCR, Inc. d/b/a Nextel Partners, and Nextel South Corp. Under the requirements of 47 U.S.C. § 252(e), negotiated agreements must be submitted to the state commission for approval. Section 252(e)(4) requires the state to reject or approve the agreement within 90 days after submission or it shall be deemed approved. The statutory deadline for the Commission to take action on this matter was May 28, 2008.

Staff reviewed the agreement in this Docket on May 21, 2008. The agreement met the criteria outlined in Section 2.07.C.5.d of the Administrative Procedures Manual. Therefore, it has gone into effect by operation of law in accordance with Section 252(e)(4) of the Telecommunications Act of 1996. Accordingly, with this Memorandum, the docket is hereby closed.
