Mr. Kleinmann,

Let me introduce myself. My name is Aaron Bowles and I am an engineer with MBV engineering and am currently representing The Spring Lake S/D WWTF. I had left messages with you and Brandon lvy and was given Junaid's number to contact regarding the subject situation. As per my discussion with Junaid, this e-mail shall serve as notification of what we are intending to do at the subject site. What has been done, as I understand, is that the WWTF re-use pond/ stormwater pond has been opened for direct discharge to an existing adjacent ditch or swale. Please note that it is my understanding that this was done to mitigate some of the stormwater problems they were encountering. Previously, however, a month ago or so the re-use water had been diverted from the re-use pond to directly discharge to some of the surrounding, limited public access golf course areas ensuring no re-use water was entering the pond that is now discharging off-site. I have recently been informed of the existing situation and understand that it may be an acceptable solution, however the FDEP may not have been properly notified of the proposed modifications. In talking with Junaid, whom happened to be very helpful, I explained our situation and expressed that we would be addressing this matter in a timely manner.

I have informed Junaid and the operator, Tom Quinn, that based on the answer we receive from you will determine if we have to close the pond up immediately or are able to wait until the issue is permitted. What I had explained to Junaid is that we don't want to close the pond up, only to find out that the beginning of next week we can open it back up. If you feel it will be a lengthier process, we can close it up now. However if you feel it is something that can be resolved in a very short period of time, we would very much chose to leave the system as is and make whatever modifications will be required upon receiving approval. There is a concern with the on-coming storms that there may be a higher potential of flooding should the pond be closed back up. Again, I am not 100% familiar with the existing storm system and will be looking into it extensively very shortly.

I hope the above makes sense and if you could please respond to the above, it would be greatly appreciated. I look forward to speaking with you on this matter.

Mr. Kleinmann

The owner of Spring Lake Golf & CC. removed a sand plug from the pond. This allowed 2-3 million gallons of storm water to leave the isolated pond and enter the canal on the NE side.

The pond has not been used for reuse for at least one month. All effluent from the wwtp has been put directly on the golf course.

The reason for removing the plug was to avoid a backup of storm water into the septic tanks at the villas. The high water level was caused by Tropical Storm Fay.
