Request for Permission from Department of Financial Services to Write-Off the Penalty Imposed on NCOM Networks, LLC in Docket No. 070711-TI/080162-TI - Compliance investigation of NCOM Networks, LLC for apparent violation of Rule

25-24.470, F.A.C. and Section 364.285, Florida Statutes

On December 14, 2007, Docket No. 070711-TI, was established to address NCOM Networks, LLC's (NCOM) failure to register as an IXC and to file a tariff, pursuant to Rule 25-24.470, Florida Administrative Code (F.A.C.).

By Order No. PSC-08-0082-PAA-TI, issued February 12, 2008, the Commission imposed a penalty against NCOM in the amount of \$25,000 for its apparent violation of Rule 25-24.470, F.A.C.

By Order No. PSC-08-0294-PAA-TI, issued May 5, 2008, in Docket No. 080162-TI, the Commission accepted NCOM's proposed settlement offer to make a voluntary contribution in the amount of \$12,500 to resolve the apparent violation of Rule 25-24.470, F.A.C. However, NCOM has failed to remit the voluntary contribution approved by Order No. PSC-08-0294-PAA-TI.

If NCOM failed to remit its voluntary contribution, the Commission ordered that NCOM shall cease and desist providing intrastate interexchange telecommunications service in Florida. The Commission further ordered that the outstanding penalty of \$25,000 be sent to the Department of Financial Services for collection, and that the Division of Administrative Services shall request permission to write-off the uncollectible amount.

Therefore, staff requests that the Division of Administrative Services/Fiscal Services Section take the appropriate steps to seek permission from the Department of Financial Services to write-off the uncollectible penalty for NCOM.
