2. Land. According to the utility's books, the Fairways systems list \$4,560 for water land and \$4,000 for wastewater land. The audit recommended reducing these amounts to \$2,000 for water and \$3,000 for wastewater based on the Lake County Tax Collector records.

Please provide documentation showing the actual cost of the land at the time it was placed into utility service and verify the size of the parcels being used for water and wastewater treatment systems.

Attached is a letter from the previous owner signifying the methodology used in determining the cost of the acreage associated with the land for the water and wastewater facilities.

Further, this methodology and results were used to calculate the cost of the acreage based on the amount of acreage that was assigned to the water and wastewater facilities.

Total Land Value was determined to be: \$52,641.53 for well sites, water and wastewater treatment plant, and lift station.

4. Revenues. According to Audit Finding No. 4, Fairways total revenues for 2003 through 2007 were \$57,995 for 2003, \$156,193 for 2004, \$346,940 for 2005, \$275,916 for 2006, and \$25 1,350 for 2007.

Please describe the reasons why revenues decreased so substantially from 2005 to 2006.

At this time, we are unable to provide an answer to this question regarding the reduction in revenues from 2005 to 2006. It is requested that the information used in the audit report be provided to Aqua so as to work with the Seller in providing an answer.

5. **Tariffs.** Staffs requested modifications to the proposed water and wastewater tariffs for the Fairways systems were provided by letter dated May 8, 2008. Included in those modifications was a request for a gallonage cap for the proposed residential wastewater tariff.

Please indicate what gallonage cap the utility is proposing for residential wastewater service.

Attached are the new and revised tariff sheets for Fairways in Lake County. Aqua intends to use the 6,000 cap for the residential service customers.
